

#### **CLASSES OF MEMBERSHIP**

- (a) Ordinary Membership is open to a person, 18 years or over.
- (b) Country membership is open to a person, 18 years or over. A Country Member's residential address must be either North of the Noosa River, South of the Tweed River, or West of Toowoomba.
- (c) Joint Membership is open to two people, both of whom are 18 years or over, who would otherwise be eligible for Ordinary Membership who are in a married or de-facto relationship.\*\*
- (d) Family Membership is open to a single person 18 years or over or two people 18 years or over who are in a marriage or de facto relationship, who would otherwise be eligible for Ordinary or Country Membership, and their dependents under the age of 18 who live at same residence.\*\*
- \*\* Where residential address of an Applicant for a Joint or Family Membership is either North of the Noosa River, South of the Tweed River, or West of Toowoomba, the Subscription for that Membership shall be the applicable Country Subscription.
